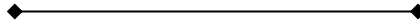

Don Bessee, with the Alta Sierra Property Association reported that the final delivery of the hydrant markers have been received. He also reported that they will be having a Town Hall meeting on March 19th and on May 11th the first responders' event will take place.

Tom O'Toole gave a brief introduction and history of himself and reported that he had just turned in an application for the Citizens' Oversight Committee. It will be placed on the agenda for the March meeting.

NEW BUSINESS

4. **Discussion and Possible Action, Joint Agreement between California Highway Patrol Valley Division Air Operations Helicopter Unit and the Nevada County Consolidated Fire District.**

Fire Chief Turner discussed the technical rescue program and reported that Captain Pat Sullivan has been instrumental working with CHP helicopter technical division. Captain Sullivan introduced himself and discussed the program. A short video clip was played regarding the program. Captain Sullivan discussed that 8 or 9 of our personnel will be part of the team that the CHP helicopter technical division will bring the training to the District. The training consists of two days, the first day in the classroom and the second day is spent hoisting. The goal of the program will be to have 2 personnel per shift.

Director Hanson motioned to enter into the Joint Agreement. Director Nelson seconded. **MOTION** passed unanimously.

5. **2019 Operational Statistics.**

Deputy Chief Funk gave a brief summary of the 2019 incident statistics. The JOA responded to 7,200 calls and reviewed the response times. Chief Funk explained that incidents are one call that the District responds to, while responses are how many units responded to an incident. The JOA had 180 working fires with an estimated \$1.8 million dollars in fire loss.

6. **Discussion and possible action, Memorandum of Understanding between Nevada Irrigation District and Fire Agencies.**

Fire Marshal McMahan reported that this is a language clean-up on the MOU. A small committee got together and met with NID and discussed the requirements of fire agencies for hydrant maintenance. One major change was the removal of flow testing due to the fact of all the requirements and costs associated with it. NID has asked that the fire departments start estimating their water usage.

Director Nelson motioned that we enter the MOU with NID. Director Garrett seconded. **MOTION** passed unanimously.

7. **Discussion and possible action, Resolution R20-02, Accepting the bid from the winning bidder for the Station 84 deck architectural services.**

Deputy Chief Funk reported that we did not get the other bid, so this item will be postponed.

8. Discussion and possible action, Request for Proposal for Fiscal Year 19/20 Financial Audit.

Finance Manager Van Groningen reported that we are required to have an annual audit as a special district and it is recommended to change auditors or partners every so often. Pehling and Pehling has completed three years and Staff requests that the District go out for a three-year proposal. Director Nelson motioned to approve the request for approval. Director Hanson seconded. **MOTION** passed unanimously.

9. Discussion and possible action, California Special Districts Association (CSDA) Board of Directors Call for Nominations Seat C.

President Grueneberg asked the Board, if there was any interest in the CSDA board. After a brief discussion, there were no Directors that had the time serve on another board.

10. Discussion and possible action, Resolution R20-03, Making Nomination to the Position of Special District Member of the Nevada County Local Agency Formation Commission (LAFCo).

President Grueneberg asked if any directors had any interest in this position. No Directors have the additional time currently, they discussed incumbent Kurt Grundel. After a brief discussion, Director Nelson motioned to support the Penn Valley Kurt Grundel as the Special District Member of the Nevada County Local Agency Formation Commission. Director Hanson seconded. **MOTION** passed unanimously following roll call vote.

11. Correspondence

CHIEF'S MONTHLY REPORT

Deputy Chief Funk reported that operationally January a routine month with statistics. Several traumatic incidents took place and Staff is monitoring the well-being of our personnel. Both formal and informal debriefings took place. The debriefing process was explained by Captain Sullivan.

On the administrative side, Safety Management was involved in a host of meetings, one being with Marysville, Linda and Olivehurst representatives inquiring information on consolidation. Deputy Chief attended a meeting with the Nevada County Superintendent of Schools with the focus on training first responders on interaction with special needs children.

Fire Marshal McMahan reported that the Fire Code was adopted, but the requirements for modular units was pulled. He also attended a meeting regarding the location of the bridge at Edwards Crossing and brought the options to the Chiefs' Association. The Fire Chiefs' Association is writing a letter of support to locate the bridge at 1,000 feet upstream from the current bridge as the best alternative.



Background:

Recently during a routine facility inspection, staff discovered significant dry rot to the substructure of the back deck at Fire Station 84. Evaluations of the deck were conducted by two construction professionals. Both recommended a complete replacement due to the extent of the damage. In order to solicit bids for replacement, a complete set of approved construction plans are necessary. The District solicited and received bids from two architectural firms to provide a proposal on services requested.

Recommendation:

Staff recommends the Board to authorize Deputy Chief Funk to accept the lowest responsible bid, and to be authorized to sign on behalf of the District, contract documents for the purpose of architectural services for the Fire Station 84 deck.

Fiscal Impact:

Funding for this project has been identified in the FY 19-20 Operating Fund 722 / Facilities Maintenance. The lowest responsible bidder is Glass Architects, submitting a bid of \$8,300.00

We are pleased to respond to the District's Request for Proposal for the Fire Station 84 Deck Replacement project.

Project Understanding

Our understanding is that the Nevada County Consolidated Fire District desires to replace the Station #84 deck, stairs and lower walkway that have been damaged by dry rot. Our drawings will show the deck replaced in its entirety with pressure treated lumber to prevent future dry rot issues. The decking surface will be a composite type decking, like Trex. The guardrails and handrails will be replaced with a pre-finished metal railing system. At this time, we are assuming the existing footings will not have to be replaced; however, our structural engineer will have to confirm this. The lower walkway will be designed as a concrete walkway with a short stem-wall. Re: Station 84 Stand-by Generator

Background:

Fire Station 84 was originally designed and equipped with a 25kw propane powered stand-by generator. This generator supplies minimal power to maintain only basic electrical functions within the facility. This has never been an optimum situation and has been compounded by the frequent public safety power shut-offs. With the move of the administrative offices to Station 84, this has increased the demand on the already undersized generator.

Staff has been researching options to provide power to the entire facility. To date, we have been able to determine the appropriate size generator to run the entire facility. We have also been working with several vendors on what additional needs will be required to upgrade our existing system. Current needs identified are; 100kw 3-phase generator, 400amp transfer switch, increased propane storage and a larger concrete pad for the generator.

Staff was recently contacted by one of our vendors of the availability of a used Kohler 100kw fully enclosed 3-phase generator. This unit has only 88 hours of use and is in excellent condition. Mechanic Greene evaluated the generator and confirmed its condition.

This generator is being offered to the District for \$18,000. Research conducted found comparable used generators listed for sale in the \$18,000 to \$22,000 range. Only one unit was comparable in the hours of use (159 hours) and was listed at \$22,000. The remaining units had 500+ hours of use. Pricing for a comparable new generator is \$26,000 to \$30,000 plus tax and shipping.

Recommendation:

The District authorize Deputy Chief Jerry Funk to purchase, on behalf of the District, one used Kohler 100kw/125kva 3-phase stand-by generator from Empire Energy Inc. for a purchase price of \$18,000.00.

Fiscal Impact:

The total cost of the generator is \$18,000.00. Funding for this project has been identified as Fund 723 Contingency.

Examples include: City Clerk, Secretary to the Board of Directors, County Clerk, etc. This person **cannot** be one of the designated Authorized Agents or Approving Board Member (if a person holds two positions such as City Manager and Secretary to the Board and the City Manager is to be listed as an Authorized Agent, then the same person holding the Secretary position would sign the document as Secretary to the Board (not City Manager) to eliminate "Self Certification.")

Amazing First Responders in Alta Sierra, Fire Station 89

On February 13, 2020, my husband was home alone and suffered a cardiac arrest. Thankfully, he was able to call 911 and talk to a dispatcher before collapsing. The dispatcher put out the call as non-responsive and the fire department was at our home in minutes. They found my husband was not breathing and quickly started CPR, and also had to defibrillate him multiple times. They took him to Sierra Nevada Hospital in GV, who sent him to Sutter Roseville.

After over 2 weeks in the ICU, he came home and is expected to make a complete recovery. This is all due to our amazing first responders in the Alta Sierra area, who never gave up on him and stayed with him every step of the way.

We'd like to give our heartfelt thanks to the Captain and his crew at Station 89, and the paramedic and EMT from the ambulance company. Without them, my husband would not be here today.

Everyone needs to know how blessed we are to live in a community with such caring and well trained first responders!!

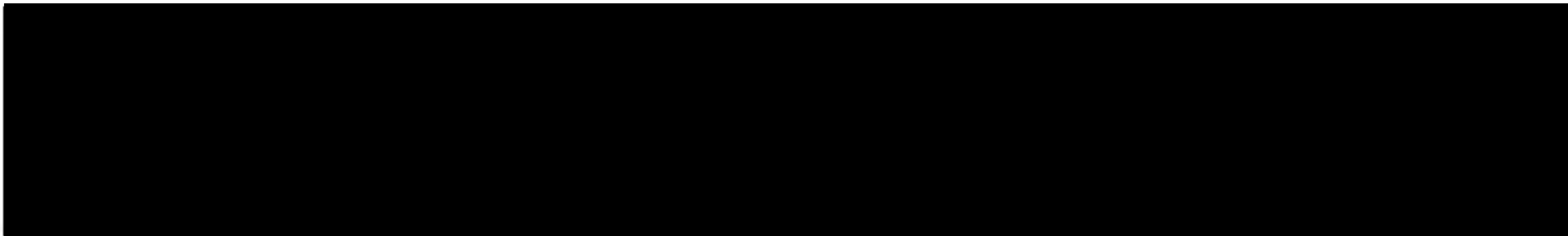

NCCFD CHIEFS' MONTHLY REPORT

OPERATIONS

Statistical data for the period of March 1 thru March 31, 2020.

- 579 calls for service. (292 emergency, 287 non-emergency)
 - Average response time urban – 3 minutes 24 seconds
 - Average response time rural - 8 minutes 33 seconds
 - Average response time overall - 5 minutes 29 seconds
- *Averages based on emergency responses only.

Significant Incidents:

- COVID 19
- Residential structure fire, Alta Sierra area. Chimney fire with extension into the attic
- Residential structure fire, Greenhorn area. A detached garage was found fully involved with minor extension to the main residence.
- Mutual aid structure fires Higgins area and Ziebright Mine area.

Training:

- 1031 hours of documented training for the month of March.
- Two firefighters attended a week-long training symposium in Nevada.
- Two captains attended a week-long technical rescue program in Nevada.

ADMINISTRATION

- The overwhelming majority of staff time was spent managing the many different impacts of COVID 19. Numerous operational and administrative procedures for the health and wellness of our staff and constituents were implemented following best practices.
- Chief Turner, Deputy Chief Funk, Battalion Chief Sunde and Fire Marshal McMahan attended the monthly Nevada County Fire Chiefs Meeting.
- Deputy Chief Funk and Fire Marshal McMahan attended the monthly CAUSSSS Meeting.
- Chief Turner attended the law enforcement / fire supervisors meeting.
- Deputy Chief Funk continued work with Glass Architects on the Station 86 remodel.

- Staff submitted the FEMA Assistance to Firefighters Grant. The District submitted a grant request for approximately \$125,000.00 of mobile radios.
- Deputy Chief Funk continued research on stand-by power options for Station 84.

FIRE PREVENTION

Engine Company Inspections:

- Due to the COVID-19 concerns we have suspended the Engine Company inspections until further notice. We will reevaluate the program and resume when it is safe to do so.

Projects:

- Prevention has received several new cannabis projects along with changes and expansions of current operations that were previously submitted.

Public Education:

- Once again, due to the COVID-19 concerns all public education station visits and outside events have been cancelled or postponed.
- The Children's Safety Fair held at the Rood Centered scheduled for May 2nd has been postponed or cancelled for this year.

Fire Investigations:

- Deputy Fire Marshal Mason investigated a structure fire in the Greenhorn Road area. This was an accidental fire and the cause is undetermined.

Meetings and Training attended by Fire Marshal McMahan:

- With Chief Turner and Deputy Fire Marshal Mason have been working with Nevada County Office of Emergency Services to renew our Memorandum of Understanding with the County to supervise the Defensible Space Inspectors.

Comments:

- Fire Marshal McMahan attended the California Fire Prevention Institute Training. This was their 30-year anniversary of putting on this training. It was well attended and a great training. If it had been scheduled one week later, it would have been cancelled.
